1. The Director of Lumsden Beach Camp Inc. reserves the right to dismiss a camper who, in his/her opinion, has displayed unacceptable behaviour and/or has not complied with the rules of the camp.
2. No refund will be made for dismissals, late arrivals or early departures.
3. As the parent(s)/legal guardian(s) of the applicant child, I am the only person / we are all of the persons having legal guardianship of the applicant child. Any conditions of custody and access, if applicable, will be fully communicated in writing to Lumsden Beach Camp Inc. with this registration.
4. I/We hereby give permission and the legal right to Lumsden Beach Camp Inc. for the use and ownership of any written or audio-visual material and photographs of the enrolled camper for publicity and promotional purposes. Should you wish to opt out of this condition, please notify the camp in writing at registration time and include a photo of your child.
5. I/We wish my/our child to take part in the full camp program unless I/We advise you otherwise in writing before the start of camp.
6. Lumsden Beach Camp Inc. is not responsible for your child on camp property until the stated registration time, and registration will not start before the stated registration time.

**Release and Waiver:** In consideration of Lumsden Beach Camp Inc. accepting this registration, I/we, as the parent(s)/ legal guardian(s) of the applicant child, for the applicant child and ourselves, our heirs, executors, administrators and assigns, release and forever discharge each of Lumsden Beach Camp Inc., The United Church of Canada and Wascana Presbytery, their respective directors, officers, servants, agents or employees from any and all claims, demands, damages, actions or causes of actions whatever in law or in equity arising out of or in consequence of any loss, injury or damage to the applicant child's person or property incurred while attending Lumsden Beach Camp Inc. or participating in any of the Lumsden Beach Camp Inc. programs or facilities, notwithstanding that any such loss, injury or damage may have arisen by reason of the negligence of any of said organizations or those for whom the said organizations are at law responsible.
